## **Use and Disclosure of Personal Information and Purpose Statement:**

Candidate personal information: name, email address, phone number, location, experience and education information, resume and other attachments submitted by the candidate on his/her own, ID No., position, department, planned start date, duration of first employment contract, work location, monthly salary, annual salary, variable bonus percentage, meal allowance, car allowance.

Bosch will keep your data confidential worldwide in accordance with the relevant data protection regulations. This system has been developed by Intelligent Recruitment Europe Ltd, St. Stephen's House, Arthur Road, Windsor, Berkshire, UK, postcode: SL41RU, and operates as a cloud-based service using an advanced encryption/decryption process between your device and the database. In case of emergency, Intelligent Recruitment Europe provides temporary access. The recruitment process is handled by Bosch Group HR, the user's department manager and other members of the recruitment team. (e.g. employees from the department you are applying for). The various managers, department employees and HR employees involved in the recruitment process may belong to different Bosch Group companies, so your data may be transferred to any of the Bosch companies. During the recruitment process, your personal information will only be provided to third parties outside Bosch (e.g. agencies) when necessary. Bosch carefully selects third-party agencies and signs confidentiality contracts with them. Your personal data will not be provided to government agencies unless required by law. Bosch has taken various confidentiality measures to protect your data from manipulation, loss, destruction, unauthorized access or disclosure. Our security measures are constantly being upgraded as new technologies are applied. The data transmission between your local browser and our talent acquisition system is encrypted via https.

## 1. Applying for a specific position

By applying for a position in the Bosch Group, you are providing your personal information to the corresponding legal entity of the Bosch Group. Please note that any changes in documents or data should be changed in all applications. You can apply for a specific position or for a non-recruiting position. In either case, you may be contacted by a member of the Human Resources department to ask if you agree to redirect your application to another suitable position within the Bosch Group. If you have applied for a specific position, Bosch will only redirect your application to another position if you agree to do so. (See section 2 below for details on applications for non-employment positions).

Please make sure that the data you provide is true and accurate. You can send new information to the designated e-mail address at any time.

If you lose interest in the vacancy you have applied for, you can withdraw your application at any time. Withdrawal of your application means that you withdraw from the competition for this position. After the application process is completed, Bosch will delete your personal information in accordance with the relevant laws. Our goal is to provide you with the most suitable position at Bosch. Therefore, we recommend that you keep it up to date by sending new documents to the non-job application form on a regular basis. By providing your contact information, you agree to be contacted by Bosch for recruitment purposes.

If you no longer wish to be contacted, please delete your application for a non-employment position, withdraw from our applicant database, and contact the relevant recruiter by e-mail.

If you withdraw your application for a non-employment position, Bosch will delete your application data after 24 months. Your personal information will not be searched for when a vacancy is available.

If you apply for a non-employment position in the United States, Bosch retains the candidate's data and information related to the position for three years in accordance with the relevant laws.

#### 4.1 Data deletion

## 5.Cross-border transfer of your personal information

We will transfer your personal information across borders with your sole consent or other legal basis, and carry out security assessments of personal information leaving the country in accordance with the law to adequately prevent and control risks and safeguard the security of your personal information.

We will delete your personal information after completing all work related to the purpose of processing personal information, except for data that must be further stored and processed in order to exercise and defend our rights, e.g. we will store your relevant personal information for the maximum period required by law and regulation to protect against legal risks, to respond to possible regulatory, criminal or civil proceedings, etc.

Our employees and our service providers are obliged to maintain the confidentiality of our transactions and to comply with applicable data protection regulations. All such persons who are granted access to data must maintain confidentiality.

We take all necessary technical and organizational measures to guarantee an appropriate level of security and to protect your data managed by us, in particular against unintentional or unlawful destruction, manipulation, loss, alteration or risk of unauthorized disclosure or unauthorized access. Our security measures will be improved periodically in accordance with technological developments.
